7. **ONTARIO LAW SOCIETY Act 13.1** is **CLEAR** the Attorney **GENERAL** for **ONTARIO** is the Official **GUARDIAN** of the **PUBLIC INTEREST** in **ALL MATTERS** having to do with "**THE LEGAL PROFESSION** and **LAW SOCIETY** in **ANY WAY**"!! 'Suspiciously the Police Direct Victims to Law Society???'
8. **POLICE** Are fully aware that case law and Jurists as, Judge Riordon had Argued that the Law Society **ON RECORD** had put the Commercial Interests of some of **ITS MEMBERS AHEAD of IT'S STATUTORY DUTY** to protect the **PUBLIC INTERESTS**, Police are directing **VICTIMS** away from the Attorney Generals' Office! 12. **THE COURTS** and **JUDGES** are **FULLY AWARE** that a lawyers' **CONVICTION** by the **LAW SOCIETY**, stands as **A CONVICTION** in **ALL COURTS** and **THAT JUDGES** are **DUTY-BOUND** to follow related courts **AND** the **PRECEDENTS SET** by higher-court Judges, (see R. vs Wijesinha, 1995 CanLII67(scc), 1995 3 scr 422). **HIDDEN IN ONTARIO** by Niagara Jurists, detrimental to the public interest.
